- **Marketing sign-ups:** Email address and marketing preferences.

B. Information We Collect Automatically

- IP address, device information, browser type
- Website usage data (pages visited, time on page, clicks)
- Cookie and tracking data

C. Information from Third Parties

We may receive information from:

- Payment processors (e.g., Stripe, PayPal)
 - Delivery companies (e.g., Royal Mail, Evri, DPD)
 - Website hosts (e.g., Wix, Shopify, Squarespace—depending on your setup)
 - Email marketing tools

4. Legal Bases for Processing Personal Data

We process your data under the following lawful bases:

- **Contractual Necessity:** To process your purchase, arrange delivery, and support your order.
 - **Legitimate Interests:** Business optimisation, fraud prevention, analytics, and customer service.
 - **Consent:** Marketing emails, SMS messages, and non-essential cookies.
 - **Legal Obligation:** Tax and accounting requirements.
 - **PECR Compliance:** Consent required for email marketing unless soft opt-in applies (existing customers purchasing similar products).

5. How We Use Your Data

We use your personal data to:

- Process and deliver orders
- Provide customer support
- Send order confirmations and delivery updates
- Manage your account
- Send marketing communications (only with consent or soft opt-in)
- Improve website performance and security

- Comply with legal obligations

We **do not** use your personal data for automated decision-making that produces legal or significant effects.

6. Cookies and Tracking Technologies

We use cookies to optimise site functionality and improve your shopping experience.

Cookie types include:

- **Essential Cookies** – required for website operation
- **Analytics Cookies** – to understand website usage
- **Functionality Cookies** – to remember preferences
- **Advertising Cookies** – to show relevant promotions

You can manage cookie settings via:

- Your browser settings

7. Data Sharing

We do not sell your personal information.

We may share data with:

- Payment processors (secure and encrypted)
- Delivery and courier partners
- Email marketing and automation systems
- Website hosting and technical support services
- Accountants or legal advisors where legally required

All third parties are contractually required to follow UK GDPR standards.

International Transfers

Where data is transferred outside the UK (e.g., US-based service providers), we ensure:

- UK International Data Transfer Agreements (IDTAs), or
- UK Addendum to the EU Standard Contractual Clauses (SCCs)

8. Data Retention

We retain your data only for as long as necessary.

- **Order & customer data:** 6 years (legal requirement).
- **Marketing lists:** Until you unsubscribe or withdraw consent.
- **Analytics data:** Up to 26 months unless otherwise necessary.

You may request deletion sooner where legally applicable.

9. Your Rights

Under UK GDPR, you can:

- Request access to your data
- Request correction of inaccurate information
- Request deletion (“right to be forgotten”)
- Object to processing
- Restrict processing
- Withdraw consent at any time
- Opt out of marketing with one click
- Request portability of your data
